Fee is to be paid **in full**, by: the end of the first day of each week of attendance. There will be a \$15.00 fee for returned or NSF checks, plus a \$10.00 per business day late fee charge until the balance is settled.

This fee is payable whether the child does or does not attend care on the days as agreed upon above. The Pavilion maintains a NO REFUND policy and make-up classes are not permitted. Prices are subject to change.

Late or overtime fees of \$15.00/half hour apply when the child is not picked up by 15 minutes after the scheduled pick-up time as noted above, and will be due and payable upon the arrival of the parent or guardian to pick up the child.

A deposit of the first week's payment is due upon registration to reserve your child's spot.

The items listed as follows will be supplied by the parents helmet, gloves, an extra set of clothes, jacket, socks and snow pants. Children are to be dressed appropriately for both

skating and for fun activities off the ice (i.e., sneakers, comfortable clothing). Please see attached supply list.

Written notification will be given by Prodigy Preschool and Childcare/ Staten Island Skating Pavilion, within a reasonable amount of time for: Days off, termination of care

Written notification will be given by the parent/guardian within a reasonable amount of time for: Termination of care, early drop off, late pick up, any change in schedule

Prodigy Preschool and Childcare/Staten Island Skating Pavilion is not obligated to hold open a child's spot after 20 absentee days by the child or without a deposit.

Waiver & Consent
